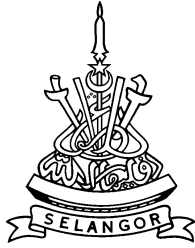

**DIPERBUAT** oleh Badan Perundangan Negeri Selangor seperti yang berikut:

**Tajuk ringkas**

1. Enakmen ini bolehlah dinamakan Enakmen Lambang-Lambang dan Nama-Nama (Mencegah Daripada Salah Guna) (Pindaan) 2016.

**Pindaan tajuk panjang**

2. Enakmen Lambang-Lambang dan Nama-Nama (Mencegah Daripada Salah Guna) 1962 [*Enakmen 13*], yang disebut “Enakmen ibu” dalam Enakmen ini, dipinda dengan menggantikan tajuk panjang dengan tajuk panjang yang berikut:

“An Enactment to prevent the improper use of certain instituted emblems and names, and conferred titles and honours by His Royal Highness the Sultan and to provide for matters connected therewith.”.

**Pindaan seksyen 1**

3. Seksyen 1 Enakmen ibu dipinda dengan menggantikan perkataan “Emblems and Names (Prevention of Improper Use) Enactment 1962” dengan perkataan “Emblems, Names, Titles and Honours (Prevention of Improper Use) 1962”.

**Pindaan seksyen 2**

4. Seksyen 2 Enakmen ibu dipinda—

(a) dengan memasukkan selepas takrif “competent authority” takrif yang berikut:

“gratification” has the meaning assigned to it in section 3 of the Malaysian Anti-Corruption Commission Act 2009 [*Act 694*];

“investiture” means the conferment of titles and dignities on a particular person by His Royal Highness the Sultan;’;

(b) dengan menggantikan takrif “specified emblem” dengan takrif yang berikut:

“specified emblem” means any emblem, seal, flag, insignia, official crest, coat of arms or pictorial representation specified in the First Schedule;’;

(c) dengan menggantikan takrif “specified name” dengan takrif yang berikut:

‘ “specified name” means any name specified in the First Schedule and include any abbreviation of any such name;’; dan

(d) dengan memasukkan selepas takrif “specified name” takrif yang berikut:

‘ “specified titles and honours” means any honours, dignities, titles, Orders and Badges of Honour and Dignity as prescribed under section 4A.’.

### **Pindaan seksyen 3**

#### **5. Subseksyen 3(1) Enakmen ibu dipinda–**

(a) dengan menggantikan perenggan (a) dengan perenggan yang berikut:

“(a) buy or use any specified emblem, specified name, or specified titles and honours, or any colourable imitation thereof for the purpose of any trade, business, calling, profession, personal gain or any other similar advantage”;

(b) dengan menggantikan perenggan (b) dengan perenggan yang berikut:

“(b) make, order, produce in any form or use or continue to use any specified emblem, specified name, specified titles and honours, or any colourable imitation thereof in the title of any patent, or in any trade mark or design; or”;

(c) dalam perenggan (c), dengan memasukkan selepas perkataan “specified emblem” perkataan “or specified titles and honours”.

**Pindaan seksyen 4****6. Seksyen 4 Enakmen ibu dipinda—**

(a) dalam subseksyen (1)—

- (i) dalam perenggan (b), dengan menggantikan perkataan “any emblem or name” dengan perkataan “any emblem, name, or titles and honours”;
- (ii) dalam perenggan (c), dengan menggantikan perkataan “any emblem or name” dengan perkataan “any emblem, name, or titles and honours”;
- (iii) dengan menggantikan perkataan “if the use of such name or emblem” dengan perkataan “if the use of such emblem, name, or titles and honours”; dan

(b) dalam subseksyen (2), dengan menggantikan perkataan “whether any emblem or name is a specified emblem or specified name” dengan perkataan “whether any emblem, name, or titles and honours is a specified emblem, specified name, or specified titles and honours”.

**Seksyen baru 4A, 4B, 4C, 4D, 4E, 4F, 4G dan 4H****7. Enakmen ibu dipinda dengan memasukkan selepas seksyen 4 seksyen yang berikut:****“Giving, receiving, using and wearing unrecognized specified titles and honours**

**4A.** (1) Any honours, dignities, titles, Orders and Badges of Honour and Dignity other than the honours, dignities, titles, Orders and Badges of Honour and Dignity instituted and conferred by His Royal Highness the Sultan shall be an unrecognized honours, dignities, titles, Orders and Badges of Honour and Dignity under this Enactment.

(2) For the purposes of subsection (1), the specified titles and honours instituted and conferred by His Royal Highness the Sultan are as follows:

- (a) any list of titles and dignities conferred by His Royal Highness the Sultan which have been published in the Selangor State *Gazette*; and
- (b) the Orders and Badges of Honour and Dignity which have been instituted by His Royal Highness the Sultan as prescribed in the Second Schedule.

(3) No person shall receive an unrecognized specified titles and honours under this Enactment from any person within the State of Selangor.

(4) No person shall give any unrecognized specified titles and honours under this Enactment to any person within the State of Selangor.

(5) No person shall use or wear any unrecognized specified titles and honours in any form whether on his body or vehicles.

(6) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than two hundred and fifty thousand ringgit and not more than five hundred thousand ringgit or to imprisonment for a term not less than one year and not more than five years or to both.

**Soliciting, receiving, giving etc. of gratification or facilitates soliciting, receiving, giving etc. of gratification for unrecognized specified titles and honours**

**4B.** (1) No person, by himself or through any other person—

- (a) solicit, receive or agree to receive for himself or for any other person; or
- (b) give, promise or offer to any person whether for the benefit of that person or of another person,

any gratification as a consideration for unrecognized specified titles and honours.



(2) No person shall facilitate any action under subsection (1).

(3) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than two hundred and fifty thousand ringgit and not more than five hundred thousand ringgit or to imprisonment for a term not less than one year and not more than five years or to both.

### **Unrecognized investiture**

**4c.** (1) No person, other than His Royal Highness the Sultan, may carry out any investiture to any person.

(2) No person shall receive any conferment from an investiture that is in contravention of this section.

(3) No person shall attend, promote, participate, facilitate or conduct an investiture in contravention of this section.

(4) No person shall rent, provide or allowed any premises for the carrying out of an investiture in contravention of this section.

(5) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than one hundred thousand ringgit and not more than two hundred and fifty thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

### **Soliciting, receiving, giving etc. of gratification or facilitates soliciting, receiving, giving etc. of gratification for organizing unrecognized investiture**

**4d.** (1) No person, by himself or through any other person—

(a) solicit, receive, or agree to receive for himself or for any other person; or

(b) give, promise, or offer to any person whether for the benefit of that person or of another person,

any gratification as a consideration for organizing an unrecognized investiture.

(2) No person shall facilitate any action under subsection (1).

(3) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than one hundred thousand ringgit and not more than two hundred and fifty thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

### **Representing as holder of specified titles and honours**

**4E.** (1) No person shall represent himself as a valid holder of any specified titles and honours instituted by His Royal Highness the Sultan, if he were not granted such specified titles and honours.

(2) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than one hundred thousand ringgit and not more than two hundred and fifty thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

### **Using revoked or withdrawn specified titles and honours**

**4F.** (1) No person shall use any specified titles and honours instituted by His Royal Highness the Sultan that has been revoked or withdrawn by His Royal Highness the Sultan.

(2) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than one hundred thousand ringgit and not more than two hundred and fifty thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

### **Using unentitled specified titles and honours**

**4G.** (1) No person shall use or enjoy any specified titles and honours instituted by His Royal Highness the Sultan in whatsoever form if they are not entitled to use and enjoy such specified titles and honours.

(2) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than one hundred thousand ringgit and not more than two hundred and fifty thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

*ILLUSTRATION*

- (a) A was conferred with a specified titles and honours by His Royal Highness the Sultan which carries a title such as Dato' Seri, Dato' Setia etc. A has four wives B, C, D and E. Only B is entitled to use the title following the husband such as Datin Seri, Datin Setia etc. as she is the first wife out of four wives.
- (b) A was conferred with a specified titles and honours by His Royal Highness the Sultan which carries a title such as Dato' Seri, Dato' Setia etc. B is married to A and she is entitled to use the title following the husband such as Datin Seri, Datin Setia etc. during their marriage period. B cannot use the title if she was divorced by A.
- (c) A was conferred with a specified titles and honours by His Royal Highness the Sultan which carries a title such as Dato' Seri, Dato' Setia etc. B is married to A and she is entitled to use the title following the husband such as Datin Seri, Datin Setia etc. A died but B can continue using the title following the late husband until she remarries again.

**Attempts and abetments**

**4H.** Whoever attempts to commit any offence punishable under this Enactment, or abets the commission of such offence, shall be punishable with the punishment provided for such offence.”.

#### **“Power to amend Schedules**

7. The Ruler in Council may, by notification in the *Gazette*, add to or alters any of the Schedules.”.

“5. The official crest of the member of the State Executive Council (EXCO), the member of the Council of the Royal Court, the Orang Besar Daerah Negeri Selangor, the Speaker of the Legislative Assembly and the member of the Legislative Assembly.”; dan

(c) dengan menggantikan Bahagian III dengan Bahagian yang berikut:

“PART III – NAMES

1. The name of His Royal Highness the Sultan.
2. The name of Her Royal Highness the Tengku Ampuan.
3. The name of Her Royal Highness the Tengku Permaisuri.
4. The name of His Highness the Raja Muda.
5. Negeri Selangor.
6. Shah Alam.”.





An Enactment to amend the Emblems and Names (Prevention of Improper Use) Enactment 1962.

[ ]

**ENACTED** by the Legislature of the State of Selangor as follows:

**Short title**

1. This Enactment may be cited as the Emblems and Names (Prevention of Improper Use) (Amendment) Enactment 2016.

**Amendment of the long title**

2. The Emblems and Names (Prevention of Improper Use) 1962 [*Enactment 13*], which is referred to as the “principal Enactment”

in this Enactment, is amended by substituting for the long title the following long title:

“An Enactment to prevent the improper use of certain instituted emblems and names, and conferred titles and honours by His Royal Highness the Sultan and to provide for matters connected therewith.”.

### **Amendment of section 1**

3. Section 1 of the principal Enactment is amended by substituting for the words “Emblems and Names (Prevention of Improper Use) Enactment 1962” the words “Emblems, Names, Titles and Honours (Prevention of Improper Use) 1962”.

### **Amendment of section 2**

4. Section 2 of the principal Enactment is amended—

(a) by inserting after the definition of “competent authority” the following definitions:

‘ “gratification” has the meaning assigned to it in section 3 of the Malaysian Anti-Corruption Commission Act 2009 [*Act 694*];

“investiture” means the conferment of titles and dignities on a particular person by His Royal Highness the Sultan;’;

(b) by substituting for the definition of “specified emblem” the following definition:

‘ “specified emblem” means any emblem, seal, flag, insignia, official crest, coat of arms or pictorial representation specified in the First Schedule;’;

(c) by substituting for the definition of “specified name” the following definition:

‘ “specified name” means any name specified in the First Schedule and include any abbreviation of any such name;’; and

(d) by inserting after the definition of “specified name” the following definition:

‘ “specified titles and honours” means any honours, dignities, titles, Orders and Badges of Honour and Dignity as prescribed under section 4A.’.

**Amendment of section 3**

5. Subsection 3(1) of the principal Enactment is amended—

(a) by substituting for paragraph (a) the following paragraph:

“(a) buy or use any specified emblem, specified name, or specified titles and honours, or any colourable imitation thereof for the purpose of any trade, business, calling, profession, personal gain or any other similar advantage”;

(b) by substituting for paragraph (b) the following paragraph:

“(b) make, order, produce in any form or use or continue to use any specified emblem, specified name, specified titles and honours, or any colourable imitation thereof in the title of any patent, or in any trade mark or design; or”; and

(c) in paragraph (c), by inserting after the words “specified emblem” the words “or specified titles and honours”.

**Amendment of section 4**

6. Section 4 of the principal Enactment is amended—

(a) in subsection (1)—

(i) in paragraph (b), by substituting for the words “any emblem or name” the words “any emblem, name, or titles and honours”;

- (ii) in paragraph (c), by substituting for the words “any emblem or name” the words “any emblem, name, or titles and honours”;
  - (iii) by substituting for the words “if the use of such name or emblem” the words “if the use of such emblem, name, or titles and honours”; and
- (b) in subsection (2), by substituting for the words “whether any emblem or name is a specified emblem or specified name” the words “whether any emblem, name, or titles and honours is a specified emblem, specified name, or specified titles and honours”.

**New sections 4A, 4B, 4C, 4D, 4E, 4F, 4G and 4H**

7. The principal Enactment is amended by inserting after section 4 the following sections:

**“Giving, receiving, using and wearing unrecognized specified titles and honours**

**4A.** (1) Any honours, dignities, titles, Orders and Badges of Honour and Dignity other than the honours, dignities, titles, Orders and Badges of Honour and Dignity instituted and conferred by His Royal Highness the Sultan shall be an unrecognized honours, dignities, titles, Orders and Badges of Honour and Dignity under this Enactment.

(2) For the purposes of subsection (1), the specified titles and honours instituted and conferred by His Royal Highness the Sultan are as follows:

- (a) any list of titles and dignities conferred by His Royal Highness the Sultan which have been published in the *Selangor State Gazette*; and

(b) the Orders and Badges of Honour and Dignity which have been instituted by His Royal Highness the Sultan as prescribed in the Second Schedule.

(3) No person shall receive an unrecognized specified titles and honours under this Enactment from any person within the State of Selangor.

(4) No person shall give any unrecognized specified titles and honours under this Enactment to any person within the State of Selangor.

(5) No person shall use or wear any unrecognized specified titles and honours in any form whether on his body or vehicles.

(6) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than two hundred and fifty thousand ringgit and not more than five hundred thousand ringgit or to imprisonment for a term not less than one year and not more than five years or to both.

**Soliciting, receiving, giving etc. of gratification or facilitates soliciting, receiving, giving etc. of gratification for unrecognized specified titles and honours**

**4B.** (1) No person, by himself or through any other person—

(a) solicit, receive or agree to receive for himself or for any other person; or

(b) give, promise or offer to any person whether for the benefit of that person or of another person,

any gratification as a consideration for unrecognized specified titles and honours.

(2) No person shall facilitate any action under subsection (1).

(3) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than two hundred and fifty thousand ringgit and not more than five hundred thousand ringgit or to imprisonment for a term of not less than one year and not more than five years or to both.

### **Unrecognized investiture**

**4c.** (1) No person, other than His Royal Highness the Sultan, may carry out any investiture to any person.

(2) No person shall receive any conferment from an investiture that is in contravention of this section.

(3) No person shall attend, promote, participate, facilitate or conduct an investiture in contravention of this section.

(4) No person shall rent, provide or allowed any premises for the carrying out of an investiture in contravention of this section.

(5) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than one hundred thousand ringgit and not more than two hundred and fifty thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

### **Soliciting, receiving, giving etc. of gratification or facilitates soliciting, receiving, giving etc. of gratification for organizing unrecognized investiture**

**4d.** (1) No person, by himself or through any other person—

(a) solicit, receive, or agree to receive for himself or for any other person; or

(b) give, promise, or offer to any person whether for the benefit of that person or of another person,

any gratification as a consideration for organizing an unrecognized investiture.

(Amendment)

(2) No person shall facilitate any action under subsection (1).

(3) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than one hundred thousand ringgit and not more than two hundred and fifty thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

**Representing as holder of specified titles and honours**

**4E.** (1) No person shall represent himself as a valid holder of any specified titles and honours instituted by His Royal Highness the Sultan, if he were not granted such specified titles and honours.

(2) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than two hundred and fifty thousand ringgit and not more than five hundred thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

**Using revoked or withdrawn specified titles and honours**

**4F.** (1) No person shall use any specified titles and honours instituted by His Royal Highness the Sultan that has been revoked or withdrawn by His Royal Highness the Sultan.

(2) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than one hundred thousand ringgit and not more than two hundred and fifty thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

**Using unentitled specified titles and honours**

**4G.** (1) No person shall use or enjoy any specified titles and honours instituted by His Royal Highness the Sultan in whatsoever form if they are not entitled to use and enjoy such specified titles and honours.

(2) Any person who contravenes this section commits an offence and shall, on conviction, be liable to a fine not less than one hundred thousand ringgit and not more than two hundred and fifty thousand ringgit or to imprisonment for a term not less than one year and not more than three years or to both.

*ILLUSTRATION*

- (a) A was conferred with a specified titles and honours by His Royal Highness the Sultan which carries a title such as Dato' Seri, Dato' Setia etc. A has four wives B, C, D and E. Only B is entitled to use the title following the husband such as Datin Seri, Datin Setia etc. as she is the first wife out of four wives.
- (b) A was conferred with a specified titles and honours by His Royal Highness the Sultan which carries a title such as Dato' Seri, Dato' Setia etc. B is married to A and she is entitled to use the title following the husband such as Datin Seri, Datin Setia etc. during their marriage period. B cannot use the title if she was divorced by A.
- (c) A was conferred with a specified titles and honours by His Royal Highness the Sultan which carries a title such as Dato' Seri, Dato' Setia etc. B is married to A and she is entitled to use the title following the husband such as Datin Seri, Datin Setia etc. A died but B can continue using the title following the late husband until she remarries again.

**Attempts and abetments**

**4H.** Whoever attempts to commit any offence punishable under this Enactment, or abets the commission of such offence, shall be punishable with the punishment provided for such offence.”.

**Amendment of section 5**

8. Section 5 of the principal Enactment is amended by substituting for the words “not exceeding one thousand ringgit” the words “not less than two hundred and fifty thousand ringgit and not more than five hundred thousand ringgit or to imprisonment for a term not less than one year and not exceeding five years or to both”.

**Amendment of section 7**

9. The principal Enactment is amended by substituting for section 7 the following section:

**“Power to amend Schedules**

7. The Ruler in Council may, by notification in the *Gazette*, add to or alters any of the Schedules.”.

**Amendment of Schedule**

10. The Schedule to the principal Enactment is amended—

(a) by substituting for the title “SCHEDULE” with the title “FIRST SCHEDULE”;

(b) in Part I—

(i) by substituting for paragraph 4 the following paragraph:

“4. The Insignias, Medals and Decorations instituted by His Royal Highness the Sultan.”; and

(ii) by inserting after paragraph 4 the following paragraph:

“5. The official crest of the member of the State Executive Council (EXCO), the member of the Council of the Royal Court, the Orang Besar Daerah Negeri Selangor, the Speaker of the Legislative Assembly and the member of the Legislative Assembly.”; and

(c) by substituting for Part III the following Part:

“PART III – NAMES

1. The name of His Royal Highness the Sultan.
2. The name of Her Royal Highness the Tengku Ampuan.
3. The name of Her Royal Highness the Tengku Permaisuri.
4. The name of His Highness the Raja Muda.
5. Negeri Selangor.
6. Shah Alam.”.
