# Tajuk ringkas

1. Enakmen ini bolehlah dinamakan Enakmen Selangor King George V Silver Jubilee (Pindaan) 2009.

#### Pindaan mukadimah

**2.** Enakmen Selangor King George V Silver Jubilee 1937 [Enakmen No. 5/1937], yang disebut "Enakmen ibu" dalam Enakmen ini dipinda dalam mukadimah dengan menggantikan perkataan "and aged Chinese in the State of Selangor" perkataan "and/or aged Chinese women in the State of Selangor and Wilayah Persekutuan Kuala Lumpur,".

#### Pindaan seksyen 5

- **3.** Enakmen ibu dipinda dengan menggantikan seksyen 5 dengan seksyen yang berikut:
  - "5. The general objectives of the Fund are for the relief of destitution and distress in the State of Selangor and Wilayah Persekutuan Kuala Lumpur by the provision and maintenance of a Home for the poor and/or aged Chinese women in the State of Selangor and Wilayah Persekutuan Kuala Lumpur and the relief of necessitous persons in the State."

#### Seksyen baru 5A hingga 5H

**4.** Enakmen ibu dipinda dengan memasukkan selepas seksyen 5 seksyen baru 5A hingga 5H yang berikut:

#### "Funds

- **5A.** The trustees shall have the following powers:
  - (a) to raise funds and to invite and receive contributions from any person or persons or organizations whatsoever by way of subscription, donation, gift or otherwise;
  - (b) to take and accept gifts of property, whether subject to any special trust or not, for the objectives of the Fund:
  - (c) to finance, pay, compensate and supplement the services provided by the Home for the health, welfare and comfort of the aged therein in the community, by the provision of facilities, buildings and equipments which may be required for the treatment of the aged and for the efficient running of the Home;
  - (d) to provide, or assist in the provision of amenities in the Home for the aged, including the provision and running of health and recreations centre, prayer rooms, and rest and convalescent areas for the use and benefit of the aged;

- (e) to undertake and execute any Charitable Trust;
- (f) to do all such things as are necessary for the attainment of the above objectives, and for the betterment of the Home.

#### **Fund Raising**

- **5B.** The Trustees shall have power exercisable from time to time as the Trustees may in their absolute discretion thinks fit and in furtherance of the declared objectives, to raise funds and invite and receive contributions from any person or persons whatsoever by way of subscriptions, donations, gifts and otherwise for the betterment of the Home in the following manner:
  - (a) to collect donations (whether periodical reports or otherwise);
  - (b) to issue appeals for donations and periodical reports on the work of the Trustees;
  - (c) to accept donations and gifts in connection with the Home so that every donation so accepted shall be subjected to the terms and conditions of the gift;
  - (d) to obtain, collect and receive money and funds by way of contributions, donations, legacies, grants and any other lawful method and accept and receive gifts of property of any description.

#### **Further endowments**

**5c.** The Trustee may receive additional donations or endowments for the general purposes of the Fund and it may also accept donations or endowments for any special objective connected with the Fund.

#### **Declaration of Trust**

- **5D.** (1) The Trustees shall stand possessed of the Fund upon trust to apply the same and the income from the Fund in the following manner:
  - (a) in and for the equipment maintenance, repair, insurance, reconstruction and general upkeep of the Home and the payment of all outgoings in connection with and the general expenses of carrying on and managing Home;
  - (b) in and for assisting the aged by the provision of food and other facilities at the Home;
  - (c) in and for as the Trustees shall in their absolute discretion thinks fit in assisting the aged or any of them by paying all or any part of their travelling expenses to and from the Home;
  - (d) in such other manner as the Trustees shall in their absolute discretion thinks fit in assisting the aged to enjoy the facilities provided by and at the Home.
- (2) The Trustees shall take into account the financial means of the aged and shall ensure that the cost to the aged of food and other facilities provided for them at the Home is kept as low as possible.
- (3) The Fund and the income of it shall be used or paid or applied exclusively for the charitable purposes in accordance to the objectives and purposes of the Fund.

#### Use of the Home

**5**E. (1) The Trustees shall use and permit the Home to be used and carried on as a Home rest, convalescence, recovery and recreation for the benefit of the aged and in accordance with such rules and regulations as the Trustees shall from time to time in their absolute discretion thinks fit.

(2) The intention being that the management of the Home and the admission of persons to the Home and the number and qualifications of such persons for admission and the duration and conditions of their residence there and all other matters in connection with the successful carrying on of the Home shall be within the exclusive cognizance of the Trustees who may make, rescind or vary at any time and from time to time the regulations and conditions which are to govern the Home without being responsible to any person in connection with such regulations and conditions.

#### Provision of Day Care services in the Home

- **5**F. (1) There shall be a Day Care Centre for the aged in the home for day care facilities and activities only.
- (2) The hours for time Day Care shall be from 7.00 a.m. to 21.00 p.m. daily on Monday to Sunday.
- (3) The Trustees will collect donations, which shall be strictly tax exempt at all material times for the provision and running of the Day Care services.

# Delegation

- **5**G. (1) The Trustees shall not be bound in any case to act personally but shall be at full liberty to employ any agent or servant to transact all or any business of whatever nature required to be done in pursuance of the Fund declared and contained in this Deed including the day-to-day management of the Home and the receipt and payment of money and shall be entitled and allowed to pay all charges and expenses so incurred by such employment and shall not be responsible for the defaults of any such agent or servant or any loss occasioned by his employment.
- (2) The Trustees shall be at full liberty to recruit and to assist in the recruitment of voluntary workers in and for the Home.

#### Daily Management of the Home

- **5H.** (1) The daily management of the home shall be by the appointed Committee.
- (2) This shall include all day to day running of the essential aspects of the Home. The Committee is fully responsible for this and shall be answerable to the Trustees on all matters.".

#### Pindaan seksyen 10

**5.** Enakmen ibu dipinda dengan memasukkan selepas perkataan "appoint." perkataan "The Trustees can open accounts in any banks as the Trustees deems fit and necessary for the proper administration and management of the Home.".

## Pindaan seksyen 12

**6.** Enakmen ibu dipinda dengan memasukkan selepas perkataan "approve." perkataan "The Trustees can invest, buy and sell movable and immovable property at any time as it is in the opinion of the Trustees essential and necessary to do so. The Trustees can further conduct any financial transaction as it is in the opinion of the Trustees essential for the proper administration and management of the Home.".

# SELANGOR KING GEORGE V SILVER JUBILEE (AMENDMENT) ENACTMENT 2009

An Enactment to amend the Selangor King George V Silver Jubilee Enactment 1937.

[

**ENACTED** by the Legislative of the State of Selangor as follows:

#### **Short title**

1. This Enactment may be cited as the Selangor King George V Silver Jubilee (Amendment) Enactment 2009.

#### Amendment of preamble

**2.** The Selangor King George V Silver Jubilee Enactment 1937 [*Enakmen No. 5/1937*], which is referred to as "the principal Enactment" in this Enactment is amended in preamble by substituting the words "and aged Chinese in the State of Selangor" the words "and/or aged Chinese women in the State of Selangor and Wilayah Persekutuan Kuala Lumpur,".

#### Amendment of section 5

- **3.** The principal Enactment is amended by substituting for section 5 the following section:
  - "5. The general objectives of the Fund are for the relief of destitution and distress in the State of Selangor and Wilayah Persekutuan Kuala Lumpur by the provision and maintenance of a Home for the poor and/or aged Chinese women in the State of Selangor and Wilayah Persekutuan Kuala Lumpur and the relief of necessitous persons in the State."

#### New section 5A to 5H

**4.** The principal Enactment is amended by inserting after section 5 the new section 5A to 5H as follows:

#### "Funds

- **5**A. The trustees shall have the following powers:
  - (a) to raise funds and to invite and receive contributions from any person or persons or organizations whatsoever by way of subscription, donation, gift or otherwise;
  - (b) to take and accept gifts of property, whether subject to any special trust or not, for the objectives of the Fund;
  - (c) to finance, pay, compensate and supplement the services provided by the Home for the health, welfare and comfort of the aged therein in the community, by the provision of facilities, buildings and equipments which may be required for the treatment of the aged and for the efficient running of the Home;
