

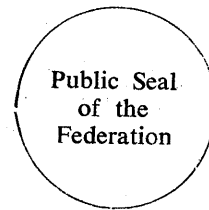
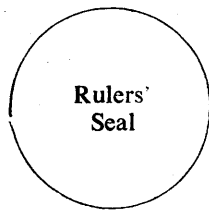

An Ordinance to amend the Municipal Ordinance in its application to a Municipality with a fully elected Council.

[30th November, 1956.]

IT IS HEREBY ENACTED by the High Commissioner of the Federation of Malaya and Their Highnesses the Rulers of the Malay States with the advice and consent of the Legislative Council as follows:

Short title and commencement.      1. This Ordinance may be cited as the Municipal (Amendment) Ordinance, 1956, and shall come into force on the thirtieth day of November, 1956.

Application.      2. The High Commissioner may, with the concurrence of the Ruler in Council in relation to a Municipality in a State and with the concurrence of the High Commissioner in Settlement Executive Council in relation to a Municipality in a Settlement, by Order apply the provisions of this Ordinance to any Municipality named in such Order.

Modification of the Municipal Ordinance (S.S. Cap. 133).  
F. of M. No. 3 of 1948.      3. (1) Where an Order has been made in accordance with the provisions of section 2 of this Ordinance, the Municipal Ordinance of the Straits Settlements in force in the Settlements and as extended to the Malay States by the Municipal Ordinance (Extended Application) Ordinance, 1948, shall in its application to the Municipality named in such Order be read and construed as if the modifications specified in the second column of the Schedule to this Ordinance were made in the sections specified in the first column of the said Schedule.

(2) The High Commissioner in Council may from time to time by notification in the *Gazette* add to, delete from, or amend the said Schedule.
